## NOTICE OF FORECLOSURE SALE

Notice is hereby given of a public non-judicial foreclosure sale.

1. Property To Be Sold. The property to be sold is described as follows:

All property (real, personal or otherwise) described in the deed of trust (as hereinafter defined as the "Deed of Trust"), together with the rights, appurtenances and improvements thereto, including, but not limited to, the real property described on Exhibit A attached hereto and made a part hereof. In the event any property encumbered by the Deed of Trust has been released by Lender (or its predecessor in interest, as applicable), then said released property shall be excluded from the property sold at foreclosure.

2. Date, Time, and Place of Sale. The sale is scheduled to be held at the following date, time, and place:

**Date: Tuesday, January 5, 2021.**

**Time: The sale shall begin no earlier than 11:00 a.m. or no later than three hours thereafter. The sale shall be completed by no later than 2:00 p.m.**

**Place: The sale will take place at the Limestone County Courthouse at the place designated by the Limestone County Commissioner's Court.**

The Deed of Trust permits the Lender (as hereinafter defined) to postpone, withdraw, or reschedule the sale for another day. In that case, the trustee or substitute trustee under the Deed of Trust need not appear at the date, time, and place of a scheduled sale to announce the postponement, withdrawal, or rescheduling. Notice of the date of any rescheduled foreclosure sale will be reposted and refiled in accordance with the posting and filing requirements of the Texas Property Code and/or Texas Business and Commerce Code. Such reposting or refiled may be after the date originally scheduled for this sale.

3. Terms of Sale. The sale will be conducted as a public auction to the highest bidder for cash, subject to the provisions of the Deed of Trust permitting the Lender to have the bid credited up to the amount of the unpaid debt secured by the Deed of Trust at the time of sale.

Those desiring to purchase the property will need to demonstrate their ability to pay cash on the day the property is sold.

The sale will be made expressly subject to any title matters set forth in the Deed of Trust, but prospective bidders are reminded that by law the sale will necessarily be made subject to all prior matters of record affecting the property, if any, to the extent that they remain in force and effect and have not been subordinated to the Deed of Trust. Prospective bidders are strongly urged to examine the applicable property records to determine the nature and extent of such matters, if any.

4. Type of Sale. The sale is a non-judicial foreclosure sale being conducted pursuant to the power of sale granted by that certain Deed of Trust (the "Deed of Trust") recorded under Instrument No. 20184368 in the Real Property Records of Limestone County, Texas, and executed by Ricky Gene Slocum (whether one or more, the "Grantor"), for the benefit of 21<sup>st</sup> Mortgage Corporation ("Lender"), covering the property described above.

5. Obligations Secured. The Deed of Trust provides that it secures the payment of the indebtedness and obligations therein described (collectively the "Indebtedness") including but not limited to the unpaid principal and interest owing on: that certain Consumer Loan Note, Security Agreement and Disclosure Statement (the "Note") dated on or about November 27, 2018, executed by the Grantor and payable to the order of Lender, and all renewals, modifications and extensions of the Note. Lender is the current owner and/or holder of the Note and the Indebtedness and is the beneficiary under the Deed of Trust.

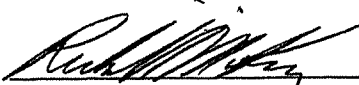

**EXHIBIT "A"**  
**LEGAL DESCRIPTION**

Being that certain 0.8767 acre tract of land, more or less, situated in the R. Flippen Survey, Limestone County, Texas, a part of Subdivision "D", Division XXIII, Town of Kosse, Texas, and a part of the 200 feet by 200 feet tract conveyed to Mrs. F.J. Ainsworth by deed describe in Volume 75, Page 369, Deed Records of Limestone County, Texas, and being more particularly described as follows:

**BEGINNING** at a 1/2" iron rod set for corner in the South right of way line of State Highway 7 at the base of an 8" cedar fence corner post;

**THENCE** N 70 degrees 23 minutes W 113.1 feet with said South right of way line of State Highway 7 to a 1/2" iron rod set at Highway P.T. Sta 768+79.59 at the base of a 4" cedar post;

**THENCE** in a Northwesterly direction with said South R-O-W line 84.2 feet along a 1 degree 30 minute curve with central angle of 1 degree 16 minutes 35 seconds, radius of 3,779.72 feet and long chord bearing N 70 degrees 43 minutes W, 64.2 feet to a 1/2" iron rod set for corner at the intersection of said South R-O-W line with the East line of Althea Street, (not open);

**THENCE** S 20 degrees 00 minutes W, 192.1 feet with said East line of Althea Street to a 1/2" iron rod set for corner, same bearing N 71 degrees 24 minutes W, 10.0 feet from a railroad tie corner post of the Ainsworth tract as fenced on the ground;

**THENCE** S 71 degrees 24 minutes E, at 10.0 feet said railroad tie fence corner post, in all 203.2 feet with a fence to a 1/2" iron rod set at the base of a 6" cedar fence corner post for Southeast corner of this tract;

**THENCE** N 18 degrees 14 minutes E, 189.1 feet with the East line of this tract and with a fence to the point of beginning, containing 0.8767 acres, more or less.
