


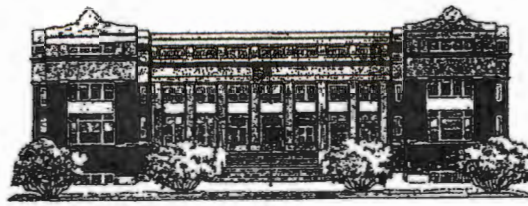

## COUNTY OF LIMESTONE, TEXAS COUNTY JUDGE DECLARATION OF LOCAL STATE OF DISASTER DUE TO MAJOR ICE STORMS STRIKING CENTRAL TEXAS

WHEREAS, the COUNTY OF LIMESTONE, TEXAS, on the 29<sup>th</sup> of January to the 4<sup>th</sup> of February, 2023, has suffered widespread or severe damage resulting from significant weather events, extreme cold, and freezing rain passing through the county and;

WHEREAS, the COUNTY JUDGE of LIMESTONE COUNTY has determined that extraordinary measures must be taken to alleviate the suffering of people and to protect or rehabilitate property,

NOW, THEREFORE, BE IT PROCLAIMED BY THE COUNTY JUDGE OF LIMESTONE COUNTY:

That a local state of disaster is hereby declared for LIMESTONE COUNTY pursuant to §418.108(a) of the Texas Government Code.

Pursuant to §418.018(b) of the Texas Government Code, the state of disaster shall continue for a period of not more than seven days from the date of this declaration unless continued or renewed by the COMMISSIONERS COURT of LIMESTONE COUNTY.

Pursuant to §418.018(c) of the Texas Government Code, this declaration of a local state of disaster shall be given prompt and general publicity and shall be filed promptly with the COUNTY CLERK.

Pursuant to §418.018(d) of the Texas Government Code, this declaration of a local state of disaster activates the LIMESTONE COUNTY emergency management plan.

That this proclamation shall take effect immediately from and after its issuance.
