**HOW TO OBTAIN A PERMIT FOR AN ON-SITE SEWAGE FACILITY**

**SINGLE FAMILY RESIDENTIAL FEE: \$310.00      ALL OTHER TYPE SYSTEMS FEE:\$510.00**  
Commercial, including multi-family dwellings

- Obtain an application from Limestone County.
- Have appropriate individual (Registered Sanitarian, Professional Engineer, or Licensed Installer) perform mandatory soil identification procedure.
- Have appropriate individual prepare planning materials. Professional design (R.S., P.E.) is required for proprietary and non-standard systems.
- Every OSSF must have an approved floodplain. This may be submitted and paid for online prior to filing your septic application OR you may submit and pay for your floodplain application at the same time as your septic application if you prefer. (\$25)
- All Aerobic systems must have an Affidavit to the Public recorded with the County Clerk's Office prior to the OSSF application being filed.
- Submit completed application and technical information sheet (in property owner's name) with all pages in intact. Include the appropriate fee and one copy each of the following: 1) planning materials; 2) site and soil evaluation; 3) accurate directions to the site must be included; 4) 2-year Maintenance Contract for Aerobic OSSF.
- Plans and application will be received by Limestone County staff. Non-standard system plans may be reviewed by TCEQ staff in Austin.
- Upon approval, an Authorization to Construct will be issued. The Authorization to Construct is valid for one year from the date of issuance.
- Begin construction. An inspection of the installation is required before covering of the system. Contact our office at least 5 business days in advance to arrange an inspection.
- After successful inspection, a Notice of Approval will be issued to the owner within approximately 5 business days.
- **NOTE:** A re-inspection fee equal to one-half (½) of the permit amount must be paid by the installer for each time the system must be re-inspected. All fees must be paid before a Notice of Approval will be issued.

**ALL FEES SHALL BE PAID BY PERSONAL CHECK, CASHIER'S CHECK, OR MONEY ORDER. NO CASH WILL BE ACCEPTED. MAKE CHECKS PAYABLE TO LIMESTONE COUNTY.**


