No "issuance expunction-certified mail" fee is required if you include the agency's email addresses in the petition/order.

For each agency you include that does not have an email address, you must pay \$13.00 for the "issue expunction-certified mail" fee.

Reminder; *Please prepare a notice of hearing, preferably one that can be signed by the court coordinator, and efile with your expunction petition.*
